1.	159 PVC - False Ceiling : Providing false ceiling made with framework of steel tube of 40mm x 20mm of not less than 18 gauge, the long and cross section will be welded with each other 1000mm to 1200mm apart the entire framework will be fixed in wall using rawplug or gutties or screws etc. And suspended from ceiling with MS flat 19mm x 3mm as necessary , the entire frame will be painted with red oxide. PRINTED LAMINATED PVC section 150mmx12mmx1.00mm (+/- 0.01mm) of approved quality and colour will be fixed on the frame so that the entire framework will not be visible from below PVC section will be fixed with the frame with the help of self tapping steel screws including all materials and labour charges including fitting, fixing the same and hoisting including mending the damages in all respect and cost of paint as required as per direction of Engineer-in-charge.	sqm	106.83
